# **COUNCIL CHAMBERS - CITY HALL**

#### **CALL TO ORDER:**

Seven Boyer, Chairman called the meeting to order at 6:00pm.

The Pledge of Allegiance was completed.

Present were Steven Boyer-Chairman, John Bebee-Vice Chairman, Karen Dinkins-Secretary and Sam Sikes-City Administrator.

A motion was made to accept the minutes of the March 23<sup>rd</sup>, 2023 meeting by Karen Dinkins. Second by John Bebee. **Motion passed.** 

DC Orr, 1117 Nevada Ave welcomed the Commission and mentioned the Commission is an independent body from the Mayor. He also stated the mayor will try to exert influence over the Commission.

# **Old Business:**

A motion was made by Karen Dinkins to adopt the Police Commission Authority document. Second by John Bebee. **Motion passed.** 

A motion was made by Karen Dinkins to approved the Libby Police Commission rules. Second by John Bebee. **Motion passed.** 

# **New Business:**

A motion was made by John Bebee to approve the Police Complaint & Grievance Form. Second by Karen Dinkins. **Motion passed.** 

Steven Boyer reviewed the minimum qualifications checklist for applicants to the police department. To date, one application from Cody Ercanbrack has been received. The application and supporting documentation was reviewed. Steven has contacted one of Cody's references at this point. It was determined the applicant meets the required qualifications know prior to an interview.

### Public Comment:

DC Orr, 1117 Nevada Ave stated if a quorum is present of the Police Commission, then the meeting must be open to the public. If necessary, the commission could then go into executive session.

Joshua Brabo, Oak St asked that the commission work with Sgt. Buckner as the only remaining officer on the force. He also asked the commission to reach out to the prior officers as there is a lot going on behind the scenes. He stated the City Administration will hide behind policies.

Steven Boyer responded that it outside the commission authority to reach out and that past officers can come forward to the commission.

Budget vs. Actual for the accounting period ending 4/23 was presented by Sam Sikes. The police department is on budget at the present time. John Bebee declared that public safety is a major priority and very vital to the City of Libby. It is important to ensure the police department has all the necessary tools.

A brief discussion of the Police Commission webpage occurred. Sam Sikes can work with the web administrator to have a new webpage for the Police Commission set up. Additionally, City of Libby emails will be set up for each commissioner. The email addresses will be the commission position and not the actual name of the commissioner in order to allow for email continuity as commissioners' term out and new commissioners are appointed. A motion was made to have Sam Sikes implement the new Police Commission webpage by Karen Dinkins. Second by John Bebee. **Motion passed.**
