# Call to Order:

# **Committee Reports:**

**Administrator:** A church group will be working in the cemetery to level out head stones and clean up the area. They will be there the 25<sup>th</sup> of May and one day in June and July.

Mr. Sikes read the building permit report. April had 1 commercial and 15 residential/other (schools and churches) building permits were issued totaling \$14,625. Since July 1, 43 permits have been sold for a total of \$36,830 in this fiscal year.

## **New Business:**

**Approve City of Libby submitting MCEP grant application for Libby Creek Community water improvements project:** Mayor Williams explained it was a two part process.

Councilor Smith **MADE A MOTION** to approve Tina Oliphant, 3BD Services, LLC. contract for grant administration, and Councilor Zimmerman **SECONDED**.

Councilors Beach, Berke, McNew, Smith, Taylor, and Zimmerman voted FOR.

## **Civics Class Presentation:**

Tripp Jong, 905 Commerce Way, along with Trey Anderson, Crystal Peña, and Tanya Ackers, lobbied for an indoor community swimming pool, stating it would provide jobs and educational opportunities like swimming lessons, lifeguard training, and exercise. A swimming pool would also generate revenue and boost community morale. Mr. Jong stated a survey was taken amongst middle school and high school students with 120 random samples. For question # 1, should Libby have a community pool? 93% answered yes. For question # 2, should the pool be indoors? 85% answered yes. For question # 3, how many want a pool on a scale from 1to 5? 53% rated it a 5, with 5% rating it a 1. After researching, several grants could be applied for to provide funding, such as National Swimming Pool Foundation, a 501C3 grant offering over \$4 million in grants. National Pool Service offers up to \$2 million in grants a year.

Mayor Williams thanked the group for their research and presentation and asked if they were aware a group had been looking into doing a pool. Mr. Jong explained he was aware and that is how their research began. Council encouraged getting involved with the group that has been looking into doing a pool.

Jordan Luizengo, 515 Minnesota Ave., along with Aiyden Crawford, Stephen Borden, and Vance Ward presented encouraging an indoor recreation facility for young adults. An indoor facility would include activities such as job fairs, community game nights, a meet or drop-off location for outdoor events and activities, used to supplement food for low-income households, and be integrated with the pool idea. The group discussed locations that would make the facility possible, and a survey example of a pie chart was given out showing high school students' support for such a facility. The group presented possible funding that could be used for such a facility, such as CDBG grant, fundraisers, memberships, vending machines, and arcade games.

Landon Haddock, 519 Nevada Ave., along with Hailey Chambers and Noah Boyd, discussed uncontrolled intersections or adding more stop signs to intersections. Mr. Haddock explained their research on safety control in the U.S. for intersections converted to traffic lights and stop signs saw a 72-80% reduction in injury crashes and a 43% reduction in total crashes. Intersections converted to roundabouts: research shows an 85% reduction in injury crashes and a 62% reduction in total crashes. The group believes that with these research numbers, such traffic control would help promote safer driving.

Mayor Williams asked if any particular intersections were identified to see traffic control. Mr. Haddock described several intersections he has had a problem at.

**Approval of Ordinance 2002, Adult Use Marijuana – Second Reading:** Mayor Williams read the Ordinance. Councilor Smith inquired about the Ordinance number being the same as one of the Resolution numbers earlier in the meeting. Clerk-Treasurer Monigold explained ordinances and resolutions have been kept in one tracking book, going forward, all ordinances and resolutions will be tracked separately.

Councilor Smith MADE A MOTION to approve Ordinance 2002, Adult Use Marijuana, and Councilor McNew SECONDED.

Councilors Beach, Berke, McNew, Smith, Taylor, and Zimmerman voted FOR.

MOTION PASSED.

**Approval of Lincoln County Commissioners' request to define Board of Health – Local Governing Body:** Mayor Williams read an email received from Lincoln County Commissioners' office and explained the request.

Councilor Smith **MADE A MOTION** that we define the Governing Body for the City-County Board of Health to include the three County Commissioners plus the Mayors from each City, with the caveat that there has to be an opportunity for a tie-breaking vote. So maybe we send on the message that Rexford's being included as well, and Councilor Beach **SECONDED**.

**Public Comments:** Jennifer Nelson, 1026 Washington, inquired if the email was recommending a name change. Mayor Williams explained it was not a name change just to define who the governing body is in case of an emergency.

Councilors Beach, Berke, McNew, Smith, and Taylor, and Zimmerman voted FOR.
