We are very grateful for all the help you have given us in the past. Co-operation between us is essential for us to accomplish what we do.

We have on average about 45 volunteers who put in about 7850 hours of work each year. Some work at the shelter each week cleaning, taking care of the animals, doing maintenance on the building and all the things that need doing. Some come occasionally, to help with all the other activities we have to make the shelter work.

Since we began in 2000, we have rescued and adopted out thousands of dogs and cats, helped owners spay or neuter their pets to stop the number of animals from being born. We have microchipped all our animals and offer this service to other owners. This facilitates finding the animals if they are lost. We offer low cost medical care for pet owners to help them keep their animals healthy.

In the process, we have vastly reduced the number of animals on the streets of Libby. I remember driving in from Farm to Market and seeing cats on the highway every week. Now there are none.

The rummage sale is one of our biggest fund raisers. People donate items to us to sell because they are pleased with the difference we have made for animals in the area. They eagerly wait until the doors are opened and they can come to look for things they need to buy.

We are hopeful that you will again waive the fee that we pay to use the Ponderosa Room. This saves us money we need to carry out our activities. Any money we have goes to care of the animals and is well used.

Thank you for any help you can give us. We appreciate what you have done for us in the past. We feel we offer a valuable service to the city of Libby by keeping unwanted animals off the streets.
